The appointee will assist in the coordination of Greater Bay Area (GBA) experiential learning activities. This includes planning, implementing, and aiding in GBA experiential learning activities, liaising with partner organizations, and providing logistical and pastoral support to students involved in GBA learning activities. Furthermore, the appointee will support teaching and learning activities, such as creating and delivering course materials and resources, performing student supervision, pastoral support, exam invigilation, assignment marking, etc.

Applicants for this position should hold a bachelor's degree in arts-related disciplines, preferably with some experience in providing outreach or teaching support. They should have an excellent command of both written English and Chinese, with proficiency in spoken English, Putonghua and Cantonese. They should have strong interpersonal and communication skills and should be self-motivated, well-organized, and able to work independently and under pressure.

Salary will be commensurate with qualifications and experience.

Initial appointment will be made on a fixed-term contract. Fringe benefits include the University's Voluntary Contributions to MPF Scheme or a contract-end lump sum payment (totaling up to 10% of the basic salary), leave, medical and dental benefits.
