Mr Chairman of the Council,

Mr Anthony Chow Wing-kin was admitted as a solicitor of The Supreme Court of England and Wales and The Supreme Court of Hong Kong in 1979 and 1980 respectively, before joining Baker & McKenzie in Hong Kong. He later set up his own practice, Anthony W. K. Chow & Co., and then became a partner of Peter C. Wong, Chow & Chow.

Since 1994, Mr Chow has served on various committees of the Law Society of Hong Kong, working extensively in the regulation of the legal profession, particularly in the areas of Professional Conduct and Professional Development. He was subsequently elected as President of the Law Society in 1997. During his three-year term, he made a tremendous contribution, actively advancing the reform of legal education, as well as laying the foundations for professional exchange and development between lawyers in Hong Kong and the Mainland.

Mr Chow applies his extensive experience in the regulation of the legal profession to many public services, and has served as Vice Chairman of the Estate Agents Authority, as well as a member of the Basic Law Promotion Steering Committee, The Law Reform Commission, the Legal Aid Services Council and the Standing Committee on Language Education and Research (SCOLAR). In 2003, he was awarded the Silver Bauhinia Star by the Government of the Hong Kong Special Administrative Region, for his committed involvement and outstanding performance in public affairs. He continues to passionately pursue various social causes. Currently, Mr Chow is Chairman of the Process Review Panel for the Securities and Futures Commission and a member of the Personal Data (Privacy) Advisory Committee.

Appointed as a Council Member of the Institute in 2003, Mr Chow has served in several different capacities, as Chairman of the Council's Audit Committee, Vice-Chairman of the Council's Staffing Committee and as a Member of the Task Force on University Title, providing professional advice, legal expertise and his extensive experience in monitoring and managing professional bodies. Through his wise counsel and widespread effort, the Institute's management and operations have reached ever higher levels of professionalism.

Mr Chow believes that professional knowledge and education development are two areas that thrive together as they complement each other. In recent years, he has been keenly involved in the development of education. In his position as Chairman of the Board of Governors of the Canadian International School of Hong Kong for example, he is contributing to the school's long term development and ultimately the well-being of the next generation.

Ms Barbara Fei, BBS, *Honorary Fellow*

Mr Chairman of the Council,

Ms Barbara Fei began her professional music training at the Nanking National Conservatory of Music, under the tutelage of Ding Shande and Yi Kaiji. In 1950, she moved to Hong Kong, receiving her ongoing vocal training under Professor Chao Mei-pa. In 1956, she went to Le Conservatoire National Supérieur de Musique et de Danse de Lyon in France, where she majored in vocal studies. She then studied under Madame Lotte Schöene at the renowned La Schola Cantorum in Paris.

Returning to Hong Kong in 1960, Ms Fei performed regularly on radio and television, and toured across Asia, New Zealand and the United States. Enhancing the interest of young people in both Chinese and Western choral music, she founded the Allegro Singers in 1964.

In 1980, Ms Fei received the privilege of being the first Hong Kong musician invited by the Chinese Musicians Association to perform in Beijing, Shanghai and Guangzhou. Subsequently setting up a scholarship, she also introduced various initiatives to forge closer links and promote musical exchanges between the Mainland, Hong Kong and Taiwan.

Firmly committed to music development, Ms Fei has served in an impressive array of arts organisations, acting as Chairman of the Music Committee of the Hong Kong Arts Development Council, Music Director and Conductor of the Allegro Singers, Chairman of the Ethnomusicological Society of Hong Kong, Senior Advisor of the Hong Kong Chinese Orchestra, as well as Music Director and Conductor of the Hong Kong Oratorical Society, among others.

Ms Fei also serves as Chairman of the Hong Kong Association of Choral Societies. She has organised numerous vocal music forums, academic conferences and major choral concerts, to advance Hong Kong's choral art. She is also an Honorary Research Fellow of the University of Hong Kong's Centre of Asian Studies and Music Advisor to the Leisure and Cultural Services Department. In 2001, she received the Bronze Bauhinia Star from the Chief Executive of the Hong Kong Special Administrative Region. In 2006, she became a member of the National Committee of the China Federation of Literary and Art Circles, and in June 2008, she received an Honorary Fellowship from the Hong Kong Academy for Performing Arts.

Mr Chairman, on behalf of the Hong Kong Institute of Education, may I present Ms Barbara Fei to you for the award of Honorary Fellowship, in recognition of her long-term dedication to academic exchanges in music, zealous promotion of Hong Kong's music culture, and tremendous contribution to Hong Kong's choral arts.

Mr Ho Siu-lun, *Honorary Fellow*

Mr Ho Siu-lun graduated from Northcote Training College in 1953, the 9<sup>th</sup> class of graduates since the College's establishment. While working as a teacher, Mr Ho also pursued his further studies, obtaining a Bachelor of Science Degree with Special Honours in Mathematics from London University in 1961. In 1974, he received his Master of Arts Degree in Education from The Chinese University of Hong Kong.

A passionate educator, Mr Ho's first teaching grounds were at King's College, Yau Ma Tei Government Primary School and Victoria Technical Secondary School. Then in 1962, he began his career in teacher education, becoming a Lecturer of Mathematics at Northcote Training College. Displaying a remarkable aptitude and commitment to the nurturing of future educators, he subsequently served as Principal of the College, until his retirement in 1988.

Northcote Training College saw extensive development under Mr Ho's leadership. Unfortunately, he was unable to realise his total vision for the future of education in view of system and resource constraints at the time. This is a major regret he holds to this day. Back then, for instance, it took ten years to build a new library because of the various restrictions. Notwithstanding these frustrations, Mr Ho dedicated every moment of his tenure to Northcote's future development.

In the 1970s, he established The Hong Kong Inter-School Mathematics Olympiads, placing Hong Kong's Mathematics education development on the international landscape. A visionary leader, he was a strong advocate for the reform of the then two-year teacher education curriculum, seeking its change into a three-year programme. This move enhanced both the professional status of teachers and their development. In 1992, the government proposed the amalgamation of the five colleges of education into the autonomous Hong Kong Institute of Education that we know today. Mr Ho also played a pivotal role in this advancement process.

Mr Ho has always treated his students as if they were his own children. To quote from Confucius' *The Classic of Rite*: "his words are of substance; his action, of integrity". He is an education pioneer and an outstanding role model for educators. He is also deeply respected, not only for his sincerity and passion when teaching, but also for his ability to lead by example.

Mr Chairman, Mr Ho Siu-lun has made an invaluable contribution to teacher education in Hong Kong. On behalf of the Hong Kong Institute of Education, may I present Mr Ho Siu-lun to you for the award of Honorary Fellowship.

Dr Joseph Kwong Kai-to, MH, *Honorary Fellow*

Dr Joseph Kwong Kai-to is an exceptional educator who has achieved greatness from a humble background.

First and foremost, Dr Kwong is a respected educator who has made his mark in rural education. Since his graduation from the Rural Training College in 1953, until his retirement in 1992, Dr Kwong has devoted his entire career to teaching in Hong Kong's more remote primary and secondary schools. Deeply connected to his roots in Hong Kong's villages, he has worked tirelessly to nurture generations of young people in the rural areas. Not only has his work changed the face of rural Hong Kong, it has also made a lasting contribution to the modernisation of the territory.

Extending his passion and expertise, Dr Kwong has also devoted a great deal of effort towards rural education on the Mainland. In 1996, riding on the Rural Training College's 50th Anniversary Golden Jubilee celebrations, he mobilised the College's alumni and members of the community, to establish the Rural Teachers' Good Service Award Scheme. Apart from supporting rural education in North Guangdong's impoverished areas, the initiative also helped to found 13 Rural Training College Golden Jubilee "Xiwang" Schools (Schools of Hope) in provinces such as Guizhou, Fujian, Guangxi, Yunnan, Anhui, and Guangdong, winning the respect of the local people.

Dr Kwong is a social activist in the field of education, advocating and supporting a range of social causes in Hong Kong's education sector. In his time, he has served as: Chairman of the Rural Training College Alumni Association; Chairman, New Territories East, Scout Association of Hong Kong; Chairman, Advisory Board, Tai Po District Arts Advancement Association; Honorary President, Tai Po Pre-Education and Kindergarten Heads Association; Honorary President, New Territories School Heads Association; President, Tai Po Association for the Promotion of Educational Exchange; and President of the North Kowloon Lions Club. His work has greatly advanced the development of foundation education and culture. His leadership in the establishment of the Primary and Secondary School Choir Promotion Scheme, when serving with the Tai Po District Arts Advancement Association, has not only benefited schools in the Tai Po District, but also students of our then Music Department, making a major contribution to the Institute.

For upcoming generations aspiring to join the education profession, Dr Kwong has set himself as a role model with his social contributions as well as his passion for education and his students, both in Hong Kong and on the Mainland. Mr Chien Lee, *Honorary Fellow*

Mr Chien Lee attended primary school at St Paul's Co-educational College in Hong Kong before going abroad for his secondary education. After obtaining a Bachelor's degree and two Master's degrees from Stanford University in the United States, he spent several years at Morgan Stanley in New York. Returning to Hong Kong in 1983, he worked in various capacities for his family's enterprise. Currently Mr Lee serves as a Director for such prestigious companies as Hysan Development Company Limited, Swire Pacific Limited and Television Broadcasts Limited. Most of his time, however, is now spent on philanthropy.

Among the many philanthropic causes to which he generously devotes himself, Mr Lee has a particularly focused commitment to education. For over 20 years he has served in various advisory and official capacities for a range of institutions, from secondary schools to tertiary institutions in Hong Kong and the United States.

Coming from a family that deeply values education, Mr Lee has built on this proud tradition. From supporting classroom education and the training of future educators, to character building for young people through his involvement in Outward Bound, Mr Lee is particularly proud of his time as Chairman of Outward Bound Hong Kong in the 1990's. He is especially pleased that the concept of Outward Bound courses, as an educational experience rather than simply an outdoor interest, has been successfully communicated and accepted by many local schools, which have since adopted these courses as a co-curricular activity.

His expertise in governance and financial management has proven invaluable to the Hong Kong Institute of Education, where, from 2006-2009 he served as a Council member and Vice Chairman of the Finance Committee; a member of the Investment Sub-Committee; a Director of the School of Continuing and Professional Education; and a member of the Working Group on the Development Blueprint (for University Title). In particular, his investment management experience made him a strong proponent for the establishment of the Investment Sub-Committee and the setting up of comprehensive investment policies. The Institute is thus more focused in the investment of its funds and thereby in maintaining a stronger financial position.

Mr Lee regards education as one of the best investments to be made in a community. A robust and well-rounded education, he believes, holds the key to upward mobility and a better life for future generations.

Mrs Rita Mansukhani Au Hay-lun, *Honorary Fellow*

Mrs Rita Mansukhani graduated from The Chinese University of Hong Kong. She then received a Master of Education (Special Education) Degree from the University of Sydney, Australia. She had served at the Special Education Section of the then Education Department of Hong Kong, and had also managed seven centres for special education services in Australia. In 1999, she became the Principal of the Hong Kong Red Cross Princess Alexandra School, holding the position until her retirement in 2009. Her contribution to Hong Kong's special education has been tremendous.

Greatly valuing the rights and dignities of students with special education needs, Mrs Mansukhani seeks to create equity in learning and full participation. Under her leadership, Princess Alexandra School became the first special school to adopt the theory of Invitational Education, a concept developed in the United States to realise the potential in mainstream students. To create a more caring environment conducive to learning, she made every effort to secure funding to rebuild the boarding section of the School, and to lead her staff in efforts to improve learning and teaching. Building confidence in her physically disabled students, she launched a series of adventure-based activities utilising mobile facilities. With her active promotion of student participation in physical and aesthetic activities, the School has become the cradle for team members representing Hong Kong in sports for physically disabled people. Her students have brought triumphs to Hong Kong by winning various championships in international athletics, fencing, and boccia competitions. These achievements are all grounded in her "equal opportunity" convictions. She has said, "No matter how many difficulties we face in the process, I firmly believe that our school should provide every student with the same opportunities available in mainstream schools." She is deeply admired and respected by her teaching staff, students and parents.

Mrs Mansukhani has served as the Chairperson of the Hong Kong Special Schools Council and as a member of the Education Commission, among other public service responsibilities. After her retirement, she has remained active and continued to serve on the Quality Education Fund Steering Committee, The Chief Executive's Award for Teaching Excellence Steering Committee and the Mental Health Review Tribunal. She also works closely with the Institute in the professional development of special education teachers. In addition to facilitating the collaboration between the Institute and the Hong Kong Special Schools Council, she has strongly supported the Institute's research and development in special education, making achievements that are widely recognised in the education community.

Mrs Mak Chen Wen-ning, BBS, *Honorary Fellow*

Mrs Mak Chen Wen-ning graduated from Chung Chi College at The Chinese University of Hong Kong in 1968, receiving a Bachelor of Science Degree cum laude in Physics. She then began teaching at Queen Elizabeth School, subsequently receiving a Postgraduate Diploma in Education from the Chinese University in 1972, and a Master's Degree in Public Administration from The University of Hong Kong in 1994.

With an outstanding career spanning over 40 years in education, Mrs Mak is as much a proactive leader as an engineer of "life". Charismatic, motivating and meticulous, she holds strongly to her beliefs. This conviction has helped her stay at the forefront of education reform, which she has served with sensitivity, vision, and great accountability.

Mrs Mak has a dream for education in Hong Kong. This vision has been realised in Tin Shui Wai with her role as the founding principal of two secondary schools in the district. Profoundly concerned with student growth, teacher development, and parental participation, she believes that the progress of the world and of a nation hinges on education.

Shortly before her retirement, she initiated a hiking programme seeking to build student confidence and perseverance. On a single day, whilst devising different hiking routes for the programme, she travelled more than once, to and fro between Tin Shui Wai and the trails of Tai Mo Shan, using every available minute to record any detail that would enrich the students' learning and experiences along the hike.

Mrs Mak has over 20 years' experience in teacher education. She was the mastermind behind the first Certificate in Education curriculum when the five colleges of education were amalgamated into the Hong Kong Institute of Education. Her teachers' professional development design structure acted as a key reference for the Teacher Competencies Framework, laid down by the Advisory Committee on Teacher Education and Qualifications.

Despite her retirement in 2007, Mrs Mak's heart is still strongly attached to Tin Shui Wai. She promoted the Open University's Capacity Building Mileage Programme to women in the local community, even volunteering as an instructor. She also established the Parents Support and Learning Awards Scheme, providing financial assistance to parents in need.

Mr Wong Kam-po, BBS, MH, *Honorary Fellow*

Hong Kong top cyclist Mr Wong Kam-po joined the Hong Kong Cycling Team at the age of 17. Winning the Asian Junior Cycling Championships in 1991, his stellar career has since left tracks across five continents, and in countless international tournaments.

As a Chinese athlete, he has made numerous breakthroughs. To name but a few of Mr Wong's victories: he was a three-time champion (1995, 1996 and 1997) of the Tour de Taiwan; he has been named one of Ten Best Athletes after winning the first gold medal in the Men's Individual Road Race at the National Games since Hong Kong's handover in 1997; he further captured the gold medal in the Road Race at the Bangkok 1998 Asian Games and Doha 2006 Asian Games, as well as the 2001 Asian Championships. In the Sydney 2000 Olympics, he became the first Hong Kong athlete to compete in Track Cycling, bringing the levels of cycling in Hong Kong to new heights. In 2007, he became the first Chinese athlete to win the 15 kilometre Scratch event in the UCI Track Cycling World Championships, held at Palma de Mallorca in Spain. From this event, he also brought home the highest accolade for a cycling athlete: the much coveted Rainbow Jersey.

Hailed by the media as a *Hong Kong Treasure*, *Asia's God of The Bike*, and a *Tiger of Asia*, his indomitable spirit has helped him to overcome many difficulties before his eventual triumphs. "Set your target and give it your best, then you will have no regret" is his motto. Mr Wong's fervour for his sport and resilience in the face of difficulty sends a personal message to us all, while also creating a proud legacy for Hong Kong's athletic history. President Hu Jintao himself praised Mr Wong, saying "You are more precious than gold". (Mr Wong's name translates as Golden Treasure.)

Mr Wong is passionate about various charitable causes as well as the development of sports in Hong Kong. He takes young athletes under his wing, and offers continuous encouragement, "a cyclist's achievement is proportional to his or her commitment and sacrifice towards cycling," he said.

Mr Chairman, Mr Wong's contributions have been extraordinary, his unyielding spirit and formidable willpower are an inspiration to the people of Hong Kong. On behalf of the Hong Kong Institute of Education, may I present Mr Wong Kam-po to you for the award of Honorary Fellowship.
